FINAL MANDATE FOR THE SOCIAL ASSISTANCE AMENDMENT BILL [B17-2008]

INTRODUCTION

The Chairperson of the Portfolio Committee on Social Services & Population Development, Hon CJ de Beer, tabled the Committee's negotiating mandate as adopted by the Portfolio Committee on 02 June 2008 on the Social Assistance Amendment Bill [B17 – 2008].

PROCESS FOLLOWED

The Speaker of the Northern Cape Provincial Legislature, on receipt, referred the Social Assistance Amendment Bill [B17 - 2008] to the Portfolio Committee on Social Services and Population Development on 16 May 2008.

The Portfolio Committee received a briefing on the Bill from the Chief Director of the National Department of Social Development, Mr Thabo Rakoloti, and the Provincial Department of Social Services & Population Development at its meeting on 23 May 2008.

On 02 June 2008 the Portfolio Committee on Social Services & Population Development deliberated and considered the Social Assistance Amendment Bill [B17 – 2008].

COMMITTEE COMMENTS ON THE BILL

The Committee is of the view that the powers of the Minister will be diluted should an independent tribunal be allowed to consider all appeals and not only those specifically referred to it.

LEGAL TECHNICAL INPUTS ON THE BILL

The Committee proposes the following amendments based on the legal technical inputs on the Bill.

JUN 4.2008 12:34 #0700 P.003 /003

i) Clause 1

The ages 62 ~ 64 years should not be implied, but should for legal certainty be included in the clause.

ii) Clause 2(3)

It seems incorrect that all appeals must be considered by the tribunal.

The following amendment proposal -

- words in bold in brackets indicate omissions
 words <u>underlined</u> indicate insertions
- (3) If the Minister has appointed an independent tribunal in terms of sub-section (2)(b) [all appeals contemplated in sub-section (1)] that appeal must be considered by [that] the tribunal. (Please refer to the Committee input in paragraph 3).

COMMITTEE POSITION AT THE NEGOTIATING STAGE

The Portfolio Committee on Social Services & Population Development supports the Bill.

The Negotiating Mandate was tabled on 03 June 2008 in the House. The Committee recommended to the House to mandate the Permanent Delegates to participate in deliberations at the negotiating stage and to support the Bill, taking note of the concerns raised by the Committee. The House therefore conferred on the Permanent Delegates the authority to participate in negotiations and to raise the concerns expressed.

COMMITTEE POSITION AFTER CONSIDERATION OF NEGOTIATING MANDATE BY THE NCOP SELECT COMMITTEE

The Portfolio Committee's Negotiating Mandate indicated that the Northern Cape will support the Social Assistance Amendment Bill [B17 – 2008] on condition that the concerns raised by the Committee will also be considered.

FINAL VOTING MANDATE



INTRODUCTION

On Monday, 19 May 2008 the Speaker formally referred the Social Assistance Amendment Bill [B17-2008] - Section 76, to the Social Development Portfolio Committee for consideration and report, together with correspondence from the Chairperson of the NCOP requesting that the processing of the bill in both the NCOP and Provincial Legislatures be expedited due to the challenges experienced by the department relating to social assistance applications to older qualifying men. The Chairperson, Mr S Ngwenya, tables the Final Mandate on the Children's Amendment Bill as follows.

2. PROCESS FOLLOWED

In compliance with the request from the NCOP, a Committee meeting was urgently convened on Tuesday, 20th May 2008, for purposes of receiving a briefing on the Bill from the NCOP through Interactive Video Conferencing, which due to technical challenges, could not materialise.

The Committee agreed to convene on 22nd May 2008 to receive a briefing on the Bill from the Permanent Delegate, Hon Member Mazibuko and senior officials from the National Department of Social Development led by the Chief Director for Social Assistance, Mr Thabo Rakolotí.

While noting the challenges currently confronting the department with the processing of the applications, the Committee noted with great concern that due to legislative time tables, the Constitutional obligation of ensuring facilitation of public involvement in the consideration of legislation with greater public interest, has to be compromised

by not allowing legislatures an opportunity to interact with the public and solicit their views in the proposed amendments to the Social Assistance Act. As a result, the Committee resolved to draft a letter to the Chairperson of the Select Committee in which it is indicated that the Committee will not be in a position to provide a voting position on the negotiating mandate for the Bill until after they have had the opportunity to involve stakeholders in a public hearing on the proposed amendments. In the letter it was further highlighted that the Committee's final mandate will also contain the inputs from the public on the Bill.

On Wednesday, 4 June 2008 the Committee conducted a public hearing at Ubuntu Kraal in Soweto

The Final Mandate on the Social Assistance Amendment Bill was adopted on Friday, 6 June 2008 during the Portfolio Committee meeting.

SUMMARY OF STAKEHOLDERS SUBMISSIONS AND THE PUBLIC HEARINGS

Three hundred and thirty one (331) members of the public from the regions Tshwane, Ekurhuleni, Metsweding, Johannesburg and Sedibeng attended the hearing. A total of 18 oral and 6 written submissions were received on the Bill and a summary of these is provided hereunder

- 3.1 Should an applicant's waiting period extends beyond 90 days as provided for in the bill, material assistance that such an applicant should accordingly be extended until the matter has been resolved.
- 3.2 There was a strong view amongst the public that the eligible age for pension grants should be dropped to 55 years given the shortened life expectancy of South Africans which currently according to stats from proponents of this view stands at 47 years.
- 3.3 A minority view was expressed that pension grants must be paid retrospectively for those that shall have qualified by 1 April 2008.
- 3.4 Potential applicants should be encouraged to apply for their pension grant one year prior the date that they will be eligible for the grant to assist in speeding up the application process.
- 3.5 With regards to the composition of the tribunal, it was suggested that one representative from each province be add on to the panel.

During the hearing, representatives from the public unanimously supported the proposed amendments to the Social Assistance Amendment Bill.

4. THE OBJECTIVES OF BILL

- 4.1 The Social Assistance Act, 2004 (Act No. 13 of 2004) (the Act), currently provides that women are eligible for the old age grant when they attain the age of 60 years and men when they attain the age of 65 years. The Bill seeks to equalise the ages of eligibility for men and women over a period of time, as suggested by the Minister of Finance in his budget speech.
- 4.2 The Act currently provides that the Minister may consider an appeal against a decision of the South African Social Security Agency or that he or she may

appoint an Independent tribunal to consider such an appeal. The Bill seeks to rephrase the provision and to add that if the Minister appoints such a tribunal, all appeals against decisions of the Agency must from then on be considered by that tribunal.

5. FINANCIAL IMPLICATIONS FOR STATE

The National Treasury has approved the budget to meet the cost of the age equalisation.

6. FINANCIAL IMPLICATIONS OF THE BILL FOR THE PROVINCE

As the functions and the powers that the Minister of Social Development may decide to delegate to the provinces, these will be accompanied with adequate financial resources. The implementation of the Bill will come with the required financial resources and may therefore have a minimal financial bearing on the Province's finances.

7. PRINCIPLE OF THE BILL

The Social Development Portfolio Committee and the Gauteng Department of Social Development support the principle and the detail of the Social Assistance Amendment Bill [B17-2008].

8. FINAL VOTING POSITION ADOPTED BY THE COMMITTEE

In terms of Section 65 of the Constitution, the Social Development Portfolio Committee recommends that the House confer authority on the Gauteng Provincial Delegate/s to the NCOP to vote in favour of the Social Assistance Amendment Bill [B17-2008].
