CAPACITY CONSTRAINTS

- Supply of persons with scarce skills in areas of engineering, architecture, transport economics and town planning continued to place pressure on delivery.
- · In response to this challenge the Department succeeded in:
 - Placing 23 recently qualified graduates.
 - Appointing retired built sector professionals for both mentoring and carrying out professional work.
 - Appointing highly experienced built sector professionals on contract.
 - Retaining employed built sector professionals through increasing their remuneration to the highest scales of their respective ranks.
 - Granting of bursaries
 - Encouraging all young built sector practitioners to register as candidates with their respective professional bodies in order to enable them to ultimately get registered.

Proclaimed Municipal Main Roads

- · Municipalities are responsible for maintenance
- · 175 km's Province wide
- Subsidies paid in terms of the Road Ordinance 19 of 1976
- · General provisions:
 - Only for proclaimed Municipal Main Roads
 - Dept pays 80% of agreed project cost
 - Municipality remains the road authority
 - Municipality appoints consulting engineers, awards and manages contracts

Proclaimed Municipal Main Roads./...

- Subsidies paid as transfer payments in arrears
- Approved allocations gazetted for each municipality i.t.o annual Division of Revenue Act
