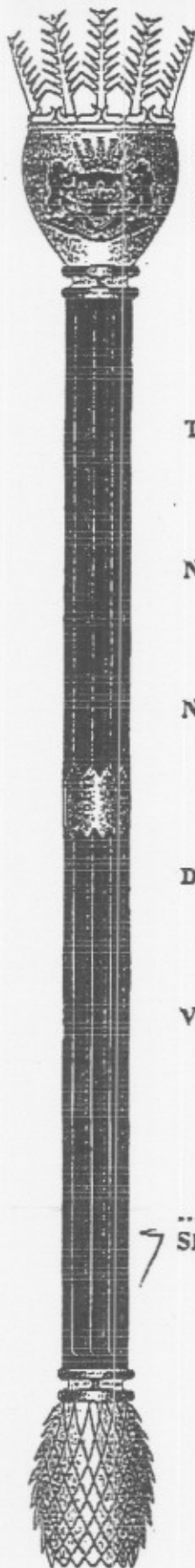

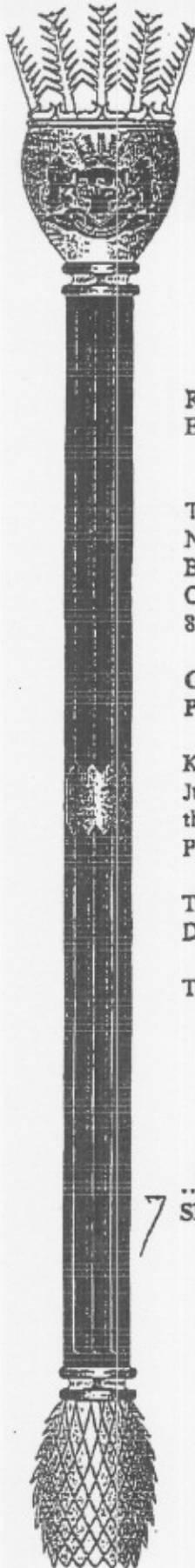

The Report of the Committee is forwarded herewith for your easy reference.

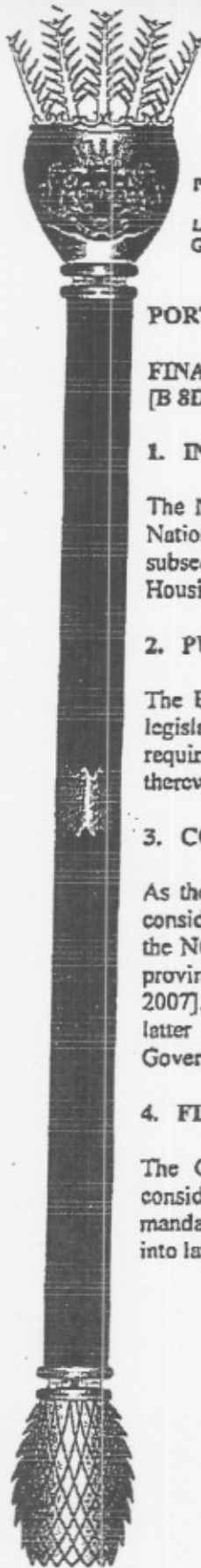

#### FINAL MANDATE ON MANDATING PROCEDURES OF PROVINCES BILL [B 8D - 2007]

#### 1. INTRODUCTION

The Mandating Procedures of Provinces Bill [B 8B - 2007] was referred by the National Council of Provinces (NCOP) to the Limpopo Legislature and the latter subsequently referred the Bill to the Portfolio Committee on Local Government and Housing for consideration and inputs and to report to this august House.

#### 2. PURPOSE OF THE BILL

The Bill seeks to provide for a uniform procedure in terms of which provincial legislatures confer authority on their delegations to cast votes on their behalf, as required by section 65(2) of the Constitution; and to provide for matters connected therewith.



#### 3. CONSIDERATION OF THE BILL

As the House may recall, during the year 2007, the Bill [B 8B-2007] was already considered by the Portfolio Committee and the House conferred a final mandate to the NCoP Delegates to vote in favour of the Bill. Having received inputs from the provinces, the NCoP Delegates, made further amendments that resulted in [B 8D-2007]. The amendments were sent to the provinces for re-consideration and for the latter to send fresh mandates on the Bill. The Portfolio Committee on Local Government and housing considered the amendments on the Bill.


#### 4. FINAL MANDATE
