OTHER CAPITAL INFRASTRUCTURE PROJECTS



- Other Capital Infrastructure projects underway:
 - Bonalesedi, Coronation, Ann Latsky, SG Lourens and Garankuwa Nursing colleges are undergoing refurbishments. All of these will be finished and ready for commissioning this year.
 - Disability access, following a report on the state of our hospitals in terms of access by the disabled, a programme has been developed to correct these deficiencies and ensure compliance with national objectives. Work will commence on 1st August 2008 and end December 2008.
 - Mental Health guidelines: new guidelines on the optimum layouts of psychiatric units in hospitals are being implemented. This has meant revisions of layouts on some Revitalization projects (Germiston and Natalspruit). The same has been addressed at Pretoria Academic Hospital where construction is ongoing. Next up is Johannesburg Hospital





OTHER CAPITAL INFRASTRUCTURE PROJECTS



- Various Rehabilitation and Repair work previously identified as maintenance projects have been escalated as capital projects owing to the size and complexity of the work needed to be undertaken.
- Upgrading of the two Anti Retroviral Treatment (ART) sites at Yusuf Dadoo and Pretoria West Hospital,



MAINTENANCE PROGRAMME

- Due to insufficient budget, maintenance programmes are being implemented mainly for statutory and planned maintenance.
- Established Facility Management Steering Committee to address & close the separations that exist between GDoH & DPTRW. DPTRW Service Improvement Strategy is being developed.
- Commenced with the process of replacing 42 lifts at 7 Health institutions.
- The GDOH advertised a tender for over 80 generators for Standby Power Generation. The tender has closed over a month ago. GSSC has since managed the Health tender as transversal, to include other provincial departments – Education and Public Works. We are now awaiting evaluation and award.





MAINTENANCE PROGRAMME....

An assessment audit was conducted on all boilers in hospitals; a report presented on boilers that needs to be replaced immediately and those that needs to be serviced. The department has requested funding to replace eleven scrapped boilers in the current financial year. A total of 87 boilers needs to be upgraded or replaced.

Payments by Public Works to Imphopoma were delayed by SCOA restructuring, hence low expenditure on maintenance projects. Budget allocations and planned projects were approved by GDOH and DPTRW, works orders were raised with imphopoma for scoping and implementation. Implementation and payment will follow.





PRIVATE PUBLIC PARTNERSHIP

- Phase 1 and 2 of the project; Technical needs and solution option analysis and comprehensive feasibility study were completed in the previous financial year.
- Gauteng Provincial Government has committed funding to the project.
- Application for Treasury Approval T/A1 was lodged with National Treasury in the first quarter of 2008/09. The GDoH has applied for Treasury Approval I with the aim of:
 - Securing a Government contribution for the Project, and
 - Securing the required budget for the Project
- Following Treasury Approval, the GDoH will proceed with the implementation plan (procurement) and address issues such as HR and site consolidation
- Partnership with Netcare at Bronkhorstspruit Hospital to lease 20 beds in operation.

- □ The following Roll overs were requested regarding Conditional Grants
 - Roll over (R53million) was requested on the hospital Revitalisation conditional grant from 2007/08 unspent commitments;
 - · Chris Hani Baragwanath Hospital, procurement of equipment, R29million and
 - · Natalspruit Hospital, construction, R24 mil
 - An amount of R10.6 million was requested to be rolled over for the Infrastructure Grant to Provinces
 - R7.1 million was requested to be rolled over on the Forensic Pathology Grant
 - Equipment including vehicles ordered in 07/08 were not delivered before 31 March
 - Facility related commitments incurred during 07/08 will only be paid in 08/09 e.g. Coldrooms

 - · In the Executive Support Programme Manager Branch dealing specifically with CAPEX grants






Capital and Maintenance Expenditure - 30 June 08

Capital and Maintenance Expenditure



- The under-expenditure on buildings relates to the unspent revitalisation and forensic pathology grants
- The under-expenditure on equipment is due to:
 - Equipment for the modernization of tertiary services (2 X PET CT) to be delivered and paid in the second half of the year
 - The business plan for the purchase of critical care beds was approved in November 07. Expenditure will start to show in the last quarter of the financial year.
 - Projections and commitments indicate a full spending of the equipment budget
- Journals to capture expenditure on maintenance have not yet been passed into the books of Health. These journals will start to reflect in the second quarter. It is expected that the full maintenance expenditure will be spent at the end of the financial year.
