Final Mandate on the Tobacco Products Control Amendments Bill (B7B-2008)

1. Terms of reference

The Tobacco Products Control Amendments Bill (B7B-2008), hereinafter referred to as the Bill, was referred to the Portfolio Committee on Health by the NCOP Business Committee for consideration.

2. Consideration of the Bill

The Portfolio Committee was briefed on the content and effect of the Bill by the special delegate, Hon. H Malgas and the officials from the Department of Health. The Committee also conducted public hearings in all the districts in the Province from the 11th to the 15th of August 2008. The Committee considered the response of the Department on the negotiating mandate of the Province and was of the view that tobacco industry should at least be allowed contact with individual consenting adults.

3. Resolutions

The Committee resolved that the following final mandate be conferred:

(1) Vote for the adoption of the Bill (B7B-2008) without amendments that will alter the principle of the Bill.

HEALTH COMMITTEE FINAL VOTING MANDATE ON THE

TOBACCO PRODUCTS CONTROL AMENDMENT BILL [B7B-2008] (Section 76)

16 September 2008,

1. INTRODUCTION

The Chairperson of the Health Committee, Dr. R. A. M. Salojee, tables the Committee's Final Voting Mandate on the Tobacco Products Control Amendment Bill [076-2008], a Section 76 Bill, as follows:

2 PROCESS FOLLOWED

The Speaker formally referred the Tobacco Products Control Amendment Bill [B7B-2006] Section 76 Bill to the Portfolio Committee on Health, in terms of the Gauteng Provincial Legislature Standing Rule 232 (1) for consideration and report on Friday, 37 June 2008

On Thursday, 07 August 2008, the Health Portfolio Committee was briefed by the Henourable Permanent Delegate, Ms Faith Mazibuko from the National Council of Provinces on the intentions of the Bill, and Mr Tsopane Monyemgangene, a Legal Assistant from the Gauteng Department of Health on the legalities of the bill. The Committee had an opportunity to make deliberations on the Tobacco Products Control Amendment Bill [B7B-2008]

On 29 August 2008, the Legal Advisor, Mr Shakespear Ncube from the GPL NCOP unit procented the legal opinion to the Committee. Subsequently, the Committee concidered a draft report on public hearings on the Tobacco Products Control Amendment Bill [B7B-2008], Section 76 Bill.

On Tucoday, 16 September 2008, the Committee considered and adopted the Final Voting Mandate on Tobacco Products Control Amendment Bill [B78-2008]

3. INTERACTION WITH STAKEHOLDERS

The Committee held a public on 19 August 2008 at the Johannesburg City Hall, Gauteing Provincial Legislature. Five hundred and twenty five (525) people who included the general public and various stakeholders attended the hearing. Key Stakeholders who attended includes. Tobacco Institute of South Africa (TISA), British American Tobacco South Africa (BATSA), Japan Tobacco Industry (JTI), National Council Against Smoking (NCAS), Cancer Association of South Africa.

Majority of the responses supported the Bill

4. IMPLICATIONS OF THE AMENDMENTS ON THE PROVINCE

4. FINANCIAL IMPACT

The Committee noted positive financial implications for the state, in terms of an additional revenue that will be generated as a result of the prohibition of duty-free and fax free sales of tobacco.

With regards to the assessment of the social impact of the Bill the Committee environged, and as confirmed by the Department, that the Bill will serve to protect the health of the public through Departmental health promotion activities that aims to discourage people from smoking

5 FINAL POSITION ADOPTED BY THE COMMITTEE

In terms of Section 65 of the Constitution the Health Portfolio Committee recommends that, the House confer authority on the Gauteng Provincial Delegate/s to NCOP to vote in favour of the Tobacco Products Control Amendment Bill [B78-2000]
