**MANDATE OF THE KWAZULU-NATAL PROVINCIAL LEGISLATURE:**

The Provincial Standing Committee on National Council of Provinces Matters met today, Friday, the 17<sup>th</sup> of OCTOBER 2008, to consider their final mandate on the Prevention of and Treatment for Substance Bill [B12B-2008].

The Committee noted the agreed amendments in the draft minutes of the Select Committee of the 9 and 23 September 2008, and that no amended Bill containing these amendments had been received for their consideration.

Therefore, the Committee unanimously agreed not to confer its final voting mandate until the Bill is amended in accordance with the agreed amendments and is presented to the Committee.
