VOTE OF THE LEGISLATURE:

The Portfolio Committee on Local Government and Traditional Affairs met today, Tuesday, the 13th of October 2009, to consider the National House of Traditional Leaders Bill [B56B-2008].

The following comments and amendments were proposed on the Bill:

a) Page 5, clause 4 (3)

"(3) The election proceedings must be conducted by [the Premier or a person] an independent electoral commission designated by the Premier of the Province concerned, observed by officials of the House and the provincial department responsible for traditional affairs."

A legal opinion was requested by the Committee on the constitutionality of clause 5(1) (a) on page 5 of the Bill

The Committee agreed to mandate the KwaZulu-Natal delegation to the National Council of Provinces to support the Bill provided that the above comments and proposed amendments are considered and consolidated in the Bill.

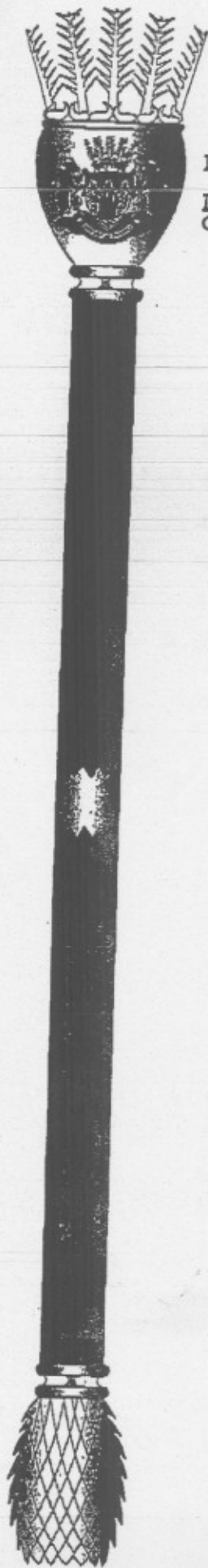


