NATIONAL HOUSE OF TRADITIONAL LEADERS BILL (B 56B-2009)**Terms of Reference**

The Bills were referred to the Portfolio Committee on Local Government and Traditional Affairs for consideration as a matter of priority

Briefing

- 2.1 On the 18 September 2009, Hon E. Chaane, an NCOP Permanent delegate, attended the briefing of the Portfolio Committee on Local Government and Traditional Affairs on the Bills.
- 2.2 Present at the briefing were Committee members the Legislature's legal advisor, delegates from the House of Traditional Leaders in the Province (including the deputy chairperson and secretary) and other members and an official from the DPSA.

Consideration

The Committee, having considered the Bill, resolved to accept and support the same to the following extent:

- Clause 8 of the Bill does not enforce relationship between local government and traditional leadership like it does in the Municipal Systems Act and SALGA constitution. More legislative provisions should be enacted to enforce this relationship;
- Clause 15 Relationship between House and provincial houses must now read:
- (5) The chairperson of the House must establish a body of Chairpersons of provincial houses to interact with the house on a regular basis on issues of mutual interest

(6) The Secretary of the House must establish a body of Secretaries of provincial houses with the House on a regular basis on issues of mutual interest

Resolution

After the committee's consideration on the Bill, the Resolution taken was

- a. To support the principle and detail of the Bill
- b. The NCOP delegates are mandated to vote in favour of the Bill, taking into consideration the proposed amendments of the committee


