What's in the name change?



- Statecraft


RELATIONS

Relations must be informed by clarity of strategy & purpose

- What is that little extra pursued above normal diplomatic interface?
 - We know the philosophy & principles underlying our conduct, but not strategy
 - What does that pattern of presidential state visits tell us?
 - What do ministerial visits tell us?

- Participation in multilaterals
- Diplomacy and tools
- Processes (decisionmaking)
- Policy outcomes
- Compliance &

Meaning of action

Basis for choices

- 15 years of great success in active participation
 - To what ultimate end?
- Extensive diplomatic presence
 - What strategic value derived (by SA)?
- Great pursuit of peace diplomacy
 - For what strategic end?
- Stronger partnerships
 - Stronger means what? size of trade, dialogue etc, - China/India/Brazil knows why, do we know?

Budget Vote suggests

- Concrete evidence of developmental dividends
 - A bold undertaking
- Foreign policy outcomes are usually strategic in the sense that they are about posture & position
- DIRCO responsible for strategic foreign policy interests - creating conditions
- Economic & social departments for taking advantage of these conditions to see to 'dividends.'
- DIRCO cannot live up to this promise ... it

Still continuity haunts us

- Annual report similar measures of success as 7-8 years ago
- Strategic partnerships, but in reality presence & participation focus continues
- Inadequate use of soft power tools persists: public, cultural and conference diplomacy
- Peripheral sub-national international relations

Still continuity haunts us

- Economic diplomacy, a younger cousin
- Occupying posts in international organizations ... how widely are we looking internally?
- Vacancy rate at DIRCO, what % is it now?
- Different approach to Zimbabwe?
- Positives like: clean audit, admin leadership continuity etc
- China & India know what they out of IBSA, but do we?

Winds of change....

- White Paper on Foreign Policy?
- IR calabash in National Strategic Plan
- Debate on a Foreign Policy Council?
- SADPA being created
- Willingness to engage non-state actors
- Friendly new headquarters tool of soft power?
- To define strategic partnership Anchor states/entities?
- Limited public engagement continues

 At least, Turfloop & Rhodes; opinion makers

But will we....

- Discuss in depth, what is the country's strategy
- Not just measure participation, presence and prudence alone, but <u>influence & impact</u>
- Debate the domestic-foreign policy connection:
 - Perception that Zuma admin is not holding together
 - Perception that Zuma is challenged ... may not last
 - How do you respond to this???

Specifics

- Our responses to shifts taking place in the global south space:
 - What is happening to configuration? IBSA BASIC
 - Do we fully understand India, China and Brazil ... and their relational challenges?
 - Do we understand what Russia is doing?
 - What is our thinking within?
- G20 indicates shift in global power structure:
 - Do we understand opportunities & threats inherent?
 - What is our strategic intervention?
 - What are we doing to set the agenda rather than mere participation and response? ... who are we talking to about this

Specifics ...

- UN Security Council rebound:
 - Are doing any reflection of wins & losses last time?
 - Are we retooling for a more successful return? capacity, capital, 'country' positions/agenda, balance?
- UN Reform: where do we stand? part of static dynamism in Africa's position? – should be <u>part or lead</u>? What does that mean?
- Nuclear Question: new ways and arguments for achieving non-proliferation? Lessons from 1995/6 and 2007-9?
- **Reform of IFIs**: what is plan A and B?
- Will we join the **OECD**: what's the purpose?
- **EU and Africa**: response to EPAs, implementation ... not initiation
- Africa's Strategic Relationships: new thinking on how
