

CENTRAL Gauteng Athletics came to the rescue of the 2010 Soweto Marathon after agreeing to host the event on November 7.

This came after Athletics South Africa failed to secure a sponsorship for the event after they reached a deadlock with Nedbank.

The bank used to bankroll all the ASA road running activities until the suspension of the Leonard Chuene-led board.

Internationally renowned runner and CGA board member Hendrick Ramaala said they were delighted that the marathon would take place as planned.

"We were under pressure from our runners, who were pleading with us to save the Soweto Marathon, hence we initiated a

meeting with the ASA on Wednesday.

"ASA interim administrator Ray Mali attended the meeting with a group of people who are doing marketing for the federation.

"It was agreed that we should form a local organising committee.

"Oom Ray was the first person to nominate himself to serve on the proposed structure. "We will also have a special

"We will also have a special CGA board meeting soon to discuss the way froward for the Soweto Marathon. We want it to be a bumper event.

"The main thing for us is to

deliver the prize money and venue for the marathon.

"If somebody sponsors the prize money we will give them the title of sponsor.

"We are over the moon that the City of Johannesburg are on board as we will have the metro police and emergency personnel working with us on the day of the marathon.

"Another plus factor is that the marathon will be shown live on television, which will help us a great deal in promoting road running in the country."

Moloi said: "We are excited
that the Soweto Marathon will go

ahead. This is major victory for the development of athletics.

"We would like to make a commitment to residents of Soweto and the rest of South Africa that the Soweto
