Industry Size


According to the TGCSA -Tourism Grading Council of South Africa as at July 2010

The Non Hotel Accommodation industry are Generally self funded and the Hotel Groups are generally equity funded.

The Guest Houses that are graded are generally compliant.

However, there are many properties that don't have all the compliances in place as there are hindrances.

Those difficulties are due to inefficient local municipalities and access to funding.



Current Compliance Requirements

We as the NAA-SA request that all our members are compliant;

- Hospitality Insurance
- Fire Regulations,
- Samro Fees
- Sampro fees,
- TV licences,
- Public Health Certificate,
- Labour Law Compliance and the Basic Conditions of Employment Act
- Liquor Licence
- Provide management accounts
- Provisional Tax Payer
- Register with the Local and Provincial Tourism Authorities
- Get Graded with the TGCSA
- Comply with the Immigration Act by keeping a register of guests



Access to Information

Access to information to compliance issues and funding needs to be easier.

Whilst there are opportunities for access to funding;

the access to information on how to go about attaining funding is almost non existent. DTI; TEP; NEF; IDC.

Most applicants don't meet the minimum qualifying criteria.

Most applicants aren't given enough information to make informed decisions



Access to Finance - Financial Institutions

When a Guest House Owner goes to the bank to borrow money to expand or become compliant, they first go to Home loans.

Home Loans don't quite understand the loan and then the Property owner is sent to commercial.

As it isn't quite a commercial venture they are either sent back to home loans or are advised to go to a Private Bank.

Some banks don't even want to finance Guest Houses as they don't understand the industry.

It is important to mention that most Guest Houses have an average of 5 rooms and employ on average 3 personnel.


If the Graded Non Hotel

Cost of Going Green


For a small Non Hotel Accommodation property to become fully compliant with the new criteria that will be launched in April 2011, it will cost in the region of R250K+

We recommend that Government Institutions together with the financial sector create a small division that understands our sector of the Hospitality and Tourism industry.



communicate with us.


Perhaps a special program needs to be introduced which encourages businesses to promote green initiatives throughout the sectors and the general population as a whole.
