Introduction


- Umvithi a youth development consultants, is the organisation of variety in youth development, education, mentoring and growth in business.

GENERAL AMENDMENT BILL [B33-2010]

The change from [Land Affairs] to Rural Development had a very big potential in –

- Maximizing funding opportunities for rural based organisations,
- > Elite branding of rural communities,
- > Attracting donors for potential sponsorships,
- > Improving market and promotional strategies,
- Minimizing risk of exploitation of rural businesses,
- Classifying the unfortunate as also part of our countries growth,

Rural Development & GDP

The change from [Land Affairs] to Rural Development has drastically improved people's lives –

- Proclamation No. 44 of 1 July 2009 the President transferred the administration powers and functions of specified legislations to the Minister of Rural Development and land reform,
- What this meant to ordinary citizens?

- >Recognition,
- > Ownership
- > Happiness
- > Growth...

Quote – Based on research conducted by the NEF

"In 2006 the Happy Planet Index of human well-being and environmental impact was introduced by the New Economics Foundation. It challenges the well-established indices of countries' development, such as Gross Domestic Product (GDP) and the Human Development Index (HDI), which is regarded as too limiting and not taking sustainability into account.

Using life expectancy, life satisfaction and the ecological footprint of countries, the Happy Planet Index tries to measure quality of life or social progress in more holistic and psychological terms than Gross National Product or GDP. This research and discussions on activities and policies actually contributing to happier societies featured strongly at the 5th International Gross National Happiness Conference, held in Brazil.

The happiest people in the world in 2009 seem to be the Costa Ricans. Costa Rica scored the highest (76.1 out of 100) on the Happy Planet Index. Not only do Costa Ricans have the highest life satisfaction in the world but they also have the second-highest average life expectancy of the New World (second only to Canada).

The highest-placed Western nation is the Netherlands – 43rd out of 143. The UK still ranks midway down the table – 74th, behind Germany, Italy and France. The USA comes a long way back in 114th place. While China was ranked 20th, it has dropped from its previous position despite the many benefits of the move to a market economy.

Egypt shines in the 12th position, while Sub-Saharan countries make up the bottom of the list, except for South Africa, we moved up from 156th in 2006 to the 118th position in 2009. Although we strive to be in the top ten we are pleased that we have improved our people's lives.

GDP still remains an essential strategy to reach the goal of a better life for all our people.


- > The study informs us that;
- The presidents proclamation made an impact in the lives of ordinary South African Citizens, which might have not been recognised, but made a huge difference that it was even picked-up in the world study.
- Although the recession caught up with us, but no one would have imagined, the results, should the recession stroke during the time when we were down, bitter, unhappy about anything that might have been a concern.


The Capita Indicators for KZN indicates an increase in the average standard of living and an increase in labor return in the province since 2000,

The provincial GDP increased on average by 3.42 percent in real terms since 2000, whereas the provincial budget increased on average by 5.14 percent year in year on real terms since 2000.



The following table shows the contribution of the local municipalities to the district economy. Between 2002 and 2008, the GDPM for uMgungundlovu DM was estimated at an annual average of R181.6m. There was a significant growth of 33.3 percent from R158,1m in 2002 to R210,6m in 2008. uMsunduzi was the largest contributor to the District GDPM at an annual average of 73.7 percent, followed by uMngeni at 8.3 percent. The least contributor was Impendle at 1.7 percent during the same period.

The sector that contributed substantially to the GDP of municipalities in the Umgungundlovu district is Agriculture, except for Msunduzi.

Sector share of municipal total GDP 2008, tells us that;

- > The economy of our Districts depends on Agriculture
- If Impendle is the lowest contributor to the district GDPM while the highest in Agriculture, and Agriculture is the highest of the overall sectors.
- > A lot still needs to be done to improve Agri-business in the district.
- > The improvement on Agri-business, is based on a sustainable rural development,
- Out government has taken a lead, so it is for us to make it a success.

The Chinese have a saying that "when the winds of change blow, some people build shelters, others build wind mills."

The South African government chose to build "windmills" by not cutting down on infrastructure spending, the change from "Land affairs" to Rural development was the results, it could have been viewed critically and differently since it was declared during the tough times but it worth it.

Expenditure on infrastructure has been very useful in creating employment opportunities and improving the competitive advantage in the rural communities, thus minimizing the effects of recession.

As an acknowledgment of the stimulating effect of infrastructure investments, KwaZulu-Natal for its part has increased infrastructure spending from R10.8 billion in 2009/10 to R11.5 billion in 2010/11 and R12.7 billion in 2011/12.

Our premier, Dr Zweli Mkhize spelled out the priorities in his state of the province address. Therefore the focus on expenditure in the 2010/2011 budget is:

- Rural Development/Agrarian Reform
- Creating decent work & economic growth
- Fighting crime
- Education
- Health
- Nation building & good governance

- > Rural Development is now a Top Priority,
- > This causes so much explicit focus on rural economy and youth development,
- Part of this development means that; Rural youth can now develop and improve their knowledge and skills on, agriculture, tourism, handicrafts and other business and trading opportunities,
- > This development indicates a need for training that can improve rural youth's opportunity,
- The undivided attention is now paid at improved access to education through non-formal education and vocational training,

- Engagement in alternative income-generating activities, has now become the buzz word in rural areas since of the change,
- Due to further development of Rural Communities, including SMME's and Local Economic Development (LED) opportunities young people now regard traditional subsistence agriculture as a potential business.

►KZN is and Agriculture driven province; That in 2009 the Hon. Premier Dr. Mkhize launched the 1 home 1 garden and initiatives to boost commercial farming mostly owned by young people at uMngeni Municipality.

- More rural youth were opting to migrate to urban areas for work and a better life
- Due to their limited education and experience, they often end up in low-paid jobs

That is changing,

The Development of Rural Communities is bringing hope to rural youth and highlights them as problem solvers than problems to be solved,

- The previous government systems did not adequately address the needs and situations of citizens in rural communities, as this was previously limited by the previous description and terminology, especially rural youth, in their policies, programmes and projects that were meant for development.
- Under "Land Affairs" terminology, there are agencies that implemented specifically targeted programmes to address some of the critical concerns challenging rural citizens,
- Those programmes were to offer valuable opportunities to Rural Communities, however, more explicit focus on the implementation of projects was limited to "Land Affairs", as "development" was not a priority for the groups, or any organization in the rural areas.

- Rural Development" as a new terminology has played a vital role, in paving a platform even on an international level for recognition of rural South Africa societies.
- Due to this development, rural citizens can now engage in an early phases of activities, where they can express their needs and develop ownership of the activities at an early stage.
- Rural youth have considerable potential willingness to help develop their communities.
- But they need good income-generating opportunities to remain in the rural areas, which is some of the critical concerns challenging rural citizens.

Youth and Power to change their communities

- Rural youth programmes has a mission to provide rural communities with the tools and support needed to sustain individuals, and take part in the fight against hunger within rural communities,
- ➤ To be effective, the rural youth efforts needs to be guided by accurate data on rural development, which at present has a strong linkage with the power associated with the -

Minister of Rural Development and land reform.

Conclusion

Goal 1 - Of a Rural development Bill, that develops strategies to benefit rural economy,

Goal 2 - Reflect the findings of a study looking at rural youth and thus rural communities, are missing out on development opportunities more readily available to urban Youth and what can be done to turn the situation around?

Goal 3 - Improving access to basic needs and to vocational training is critically needed..

- Use agriculture to improve rural youth's livelihoods if they are taught new techniques, how to grow new crops and how to sell crops locally,
- Rural youth are open-minded and have ideas on how to improve the current situation, lets get them involved in the planning meetings not as ward councilors and izinduna's but as specialists in rural development.
- They need basic support and improved knowledge and skills to begin their development.
- Umvithi Youth Development Consultants and Rural Youth Development Foundation – SA, collaborated in activities to address this information gap

From time to time complementary activities are implemented: to address the needs established within the rural communities.


