Please note update on Feni's upcoming matters before various courts

1. 16 September 2011 _____ recession application matter, this is after Judge Potraill Ruling on 12 August 2011 to have all issues falling under this case number set down under one judge due to irregularities that had occurred since the order of 18 April 2011 and that the matter must be referred for investigation.
2. 7 September 2011 _____ Labour court application where Feni is claiming 2, 6 million against PanSALB (the matter is defended)
3. 8 September 2011 _____ CCMA Pretoria where Feni is claiming unpaid pay progression (matter is set down for Arbitration)
4. Case No: 42559/11 _____ In this matter Feni is claiming R38 million against the Board for alleged breach of contract of employment (the matter is defended, awaiting set down date from High court)
5. On 23 August 2011, Feni through his attorney Makhafola attorneys suggested a possible settlement in which he undertook to send us a formal letter, to date we await the same.
