- 1. Consol: Because Amelia can't give an audited financial report of the funds that was given to Proudly by Consol their refuse to release promised funds to proudly Manenberg why can't she give a report where has the money gone and why does the clothing corp still reflect a negative bank balance when Teba paid for last year's conference bags, klopse gear was
- manufactured and paid for by a local klopse team and Teba paid for overalls that was supposed to be made by them, so where are the money Amelia.
- 2. IDT: Refuses to work with PM until the money that was claimed by Mario and Amelia are repaid or a change in leadership should occur before the IDT comes back which means no better work and wages for the members while their still part of PM. Ask them to make IDT audit report available to members they had that report for the last 14months but didn't release that report to the members why not if you don't have anything to hide members ask Mario to give that report to you.
- 3. The City council: who has so much work to offer PM just refuses to work with us because of Mario and Amelia and they don't suffer they earn enough it's us the members and residents that suffer remember Mario or Amelia aren't residents of Manenberg so why should they care.
- 4. The DA whose is the government in Cape Town refuse to allocate work to us because of Mario and Amelia and all you members know that.

- 6. The residents don't belief in Mario that was evident during his election campaign and while on the subject Mario used the clothing sectors money that was intended for overalls for our members to fund his election campaign that's why we don't have overalls but Teba gave PM money for that purpose early in 2011
- 7. The members the majority of our members are unhappy in the field but are afraid to talk the pride, the dignity and the vibrancy has been lost and the fact that we all know that we have to take a stand and remove those who are not beneficial to Manenberg. At the end of October council are planning to implement major job opportunities in Manenberg and if Mario and Amelia is still part of PM we will miss out on that opportunity.

In short if we want better work and better wages we have to remove them from PM and that's a fact.

Is Mario in touch with Manenberg? NO

- 2.
