

FINAL MANDATE FOR THE DIVISION OF REVENUE BILL [B4–2012]

INTRODUCTION

The Chairperson of the Portfolio Committee on Finance, Economic Development & Tourism, Hon KD Molusi, tabled the Committee's negotiating mandate as adopted by the Portfolio Committee on **17 April 2012** on the *Division of Revenue Bill [B4–2012]*.

PROCESS FOLLOWED

The Speaker of the Northern Cape Provincial Legislature, on receipt, referred the *Division of Revenue Bill [B4–2012]* to the Portfolio Committee on Finance, Economic Development & Tourism.

The Portfolio Committee received a briefing on the Bill from the Northern Cape's Permanent Delegate to the NCOP, Hon C de Beer, Mr J Carter and Mr E Pillay from the National Treasury, at its meeting on **13 March 2012**.

One (1) public hearing was held on **16 April 2012** as per Committee resolution and both written and oral submissions were called for. The public engaged with the Members of the Provincial Legislature in respect of the Bill.

PORTFOLIO COMMITTEE'S POSITION AT THE NEGOTIATING STAGE

The Portfolio Committee on Finance, Economic Development & Tourism **supports** the Bill.

The House conferred on the Permanent Delegates the authority to participate in negotiations and to raise the concerns expressed.

COMMITTEE POSITION AFTER CONSIDERATION OF NEGOTIATING MANDATE BY THE NCOP SELECT COMMITTEE

The Portfolio Committee's Negotiating Mandate indicated that the Northern Cape will support the *Division of Revenue Bill [B4–2012]*.

FINAL VOTING MANDATE

In terms of Section 65 of the Constitution, the Portfolio Committee on Finance, Economic Development & Tourism recommends that the House confer authority on the Head of its Delegation to the NCOP to **vote in support** of the ***Division of Revenue Bill [B4-2012]***.
