EASTERN CAPE

- In 6 (six) Projects, the office received a certificate for the registration of Tyelerha Communal Property Association and has briefed the State Attorney to appoint the conveyancer regarding transfer of properties. The properties will be transferred by 31 May 2012.
- 1 (one) Property has been transferred to Nyathi Family Trust.
- Legal entities for Cwengwe community and Nkula family have been registered and the office has transferred 7 (seven) and 2 (two) properties respectively.

KWAZULU – NATAL

- The office is in consultation with Eastern Cape office for transfer of files regarding Mount Currie beneficiaries. 2 (two) properties are to be transferred to Luswazi family and 4 (four) to Mhlakaza family.
- 15 (fifteen) properties are to be transferred to Nkunzana community. The office is engaging with relevant parties with the intention of amicably resolving the conflict.
- 6 (six) properties were identified by the office as not Restitution claims. The office is in consultation with Provincial Land Reform Office.

LIMPOPO

- There are 13 (thirteen) competing claims on properties to be transferred to Rantho Tribal Authority. The office is conducting further research to ensure smooth transfer of properties to rightful beneficiaries.
- There is further research on 3 (three) properties to be transferred to Monageng Maepa Mathabatha and Masakaneng communities.
- There is conflict between Majadibodu and Mosima Communities and the Office has referred a case for mediation in order to transfer 6 (six) properties to rightful beneficiaries.
- There is delay in the issuance of clearance certificate by the Municipality for the transfer of 1 (one) property to Dilokwend community.

The conveyancer erroneously transferred 9 (nine) properties to the State instead of transferring to Muananzhele community legal entity. The properties will be transferred to a legal entity by 31 May 2012.

3 (three) properties to be transferred to Batlhalerwa and 1 (one) to Lethakaneng could not be finalised as a result of a conveyancer being struck from the roll of attorneys. The new conveyancer will be appointed by 30 April 2012.

Matter is before the court for transfer of 2 (two) properties to Mamahule and 1(one) to Batlokwa Ba Ga Kgosi Matlapeng.

Conflict has been resolved for the transfer of 2 (two) properties to Mamuhomi community

There is conflict regarding transfer of 3 (three) properties to Mactele. The matter is being mediated.

MPUMALANGA

- The office is currently appointing conveyancers for transfer of 1(one) property to Mbuyani, Mkhathswa and Madalaskom, 1(one) to Ntuli and Mahlangu, 3 (three) to Bochabelo land claims community, 1(one) to Maaphogolo community, 5 (five) to Molamu family, 6 (six) to Bakone Ba Phetla, 23 (twenty three) to Shongwe Tribe, 2(two) to Ten Bosch, 1 (one) for Skhosana family, 2 (two) for Lekhuleni community, 2 (two) for Ikhaba Tribe, 1 (one) for Inloop and Bosfontein, 1 (one) for Mntyali. The properties will be transferred by 31 July 2012.
- 34 (thirty four) properties are affected by competing or overlapping claims amongst Ten Bosch, Shongwe Tribe, Mlambo Tribe and Mapulana community. The Office is appointing a mediator as per court ruling.

12 properties to be transferred to Pilgrim Development Trust and 1 property to Msibi CPA. The properties will be transferred by 30 June 2012.

- 1 (one) property transferred to Mlambo Tribe and Ten Bosch and 1(one) again transferred to Mapulana community and Ten Bosch community.

- The Office is attending to the establishment and registration of legal entities for the 3 (three) properties to be transferred to Flemming family, 2 (two) properties to Menoe family and 18 (eighteen) properties to be transferred to Monye, Sehularo, Mokgosi and Hlengiwe families. The properties will be transferred by 31 July 2012.
- 7 (seven) properties transferred to Barolong Bo Phoi, 4 properties transferred to Barolong Bo Makgobi, 1 (one) property transferred to Apple Green and Mentor.
- The office is attending to the transfer of 3 (three) properties to Barolong Bo Mariba. The properties will be transferred by 30 June 2012.
