For the reasons beyond my personal control , the claim was never processed as expected and according to the legal prescripts to the extent that, I became the victim of circumstances.


I therefore on the bases of the new Bill (B.22-12) on ROAD ACCIDENT FUND request that my claim be reviewed and given all the due consideration it deserves.

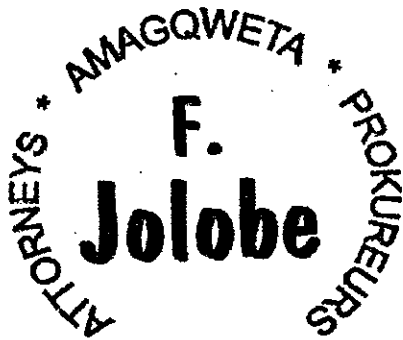

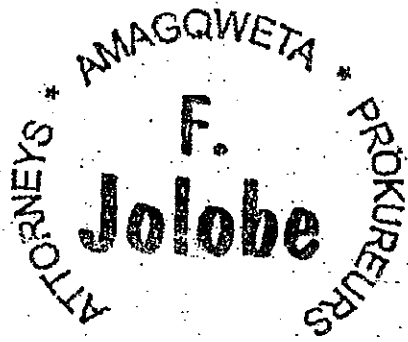

We are the managers of the Attorneys Insurance Indemnity Fund, in which capacity we have received a copy of your letter dated **22 February 2005** relating to this matter. 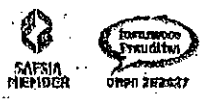
