Grant purpose – Hospital Revitalisation Grant

- To provide funding to enable provinces to plan, manage, modernise, rationalise and transform health infrastructure, health technology, monitoring and evaluation of the health facilities in line with national policy objectives; and
- To supplement expenditure on health infrastructure delivered through public-private partnerships.

Performance issues – 4th Quarter

Northern Cape

- 95% completion of Upington Hospital, department anticipated 100% but there has been slow progress on the external civil work;
- Construction of De Aar Hospital –phase I 80 % complete as at 31 March 2012; phase II - 20% complete due to late appointment of contractor by the department of Roads and Public Works;
- 63% completion of New Mental Health Hospital due to late appointment of contractor and assessment of building works by the department of Roads and Public Works;
- Kuruman, Postmasburg and Kimberley hospitals were at planning stage



Performance issues – 4th Quarter

- North West
 - Vryburg hospital completed and operational
 - Moses Kotane phase I complete, only the psychiatric ward is still being fixed to comply with the mental health requirements;
 - phase II other additions to the project are the Gateway clinic and extension of the OPD
 - Brits hospital constructed with the bulk of the Hospital Revitalisation Grant spent on it

New Mental Health Hospital

- The project started in September 2005 and completion date now revised and estimated to be November 2014.
- The original contract amount was R290 million then revised to R408 million as at 31 August 2009.
- Due to the court case that took long to be concluded, the province underspent on the grant.
- Court case has been concluded and a new contractor is appointed and on site.
- In terms of the Infrastructure Reporting Module (IRM), the province projects to spend R91.3 million in 2012/13.



Conclusion

- On aggregate provinces have spent 26 per cent faster at the end of 2011/12 financial year than in 2010/11.
- Northern Cape improved their spending significantly in 2011/12 in comparison to past 4 financial years, while North West has continuously spent their entire budget over these years.
- Delays in project implementation led to cost escalations for the New Mental Health Hospital due to poor performance by the previous contractor.
- Spending on HRP improved considerably at the end of 1st quarter when compared to same period in 2011/12, and notably Northern Cape being one of those provinces that improved.
