

IRBA, SAICA and SAIPA	Is requiring compliance with the principles of corporate governance not too onerous?	1.S3(6) provides for regulations setting out these principles. It will thus be clear and aligned to the needs of co-operatives
IRBA, Pretorium Trust	Archive documents after 7 years too onerous	1.S21(2): 5 years, or such longer period as the Minister may determine
IRBA, SAICA and SAIPA	Role of the Board vs the Auditor / Independent reviewer appears confused	1. S48 (Consideration of audited report or independent reviewed reports) Corrected
SAICA	Appointments of auditor / independent reviewer restricted (interim / higher level of governance)	1. S50(7) and (8): Interim appointments allowed so that a cooperative can choose to change level of governance at any point
