AREAS OF KEY INTERVENTION IN TAKING FORWARD ISSUES RAISED DURING TPTP, PROVINCIAL WEEK AND SPECIAL PROJECTS

Driven by the ideal of ensuring the realisation of a better quality of life for all the people of South Africa, Parliament has committed itself to be effective and responsive to the needs of the people. At the centre of realising this dream, lies the need of all spheres of government to work harmoniously as a cohesive force. Because of its character and composition as a house for provinces, the NCOP is strategically placed to ensure that there is coherent planning and ultimately seamless service delivery at all levels of government.

Within the five municipalities that were visited each municipality has unique challenges that characterises it.

Emthanjeni municipality

- In Britstown and Hanover sanitation and housing are sticky issues
- In De Aar the revitalisation of the junction may be the anchor point for the stimulation of economic activity in the municipality.
- Bulk water supply is also an important element in economic growth stimulation particularly for industrial use.

Renosterberg municipality

This municipality has a facility that could be used as an anchor for job creation in the form of the Vanderkloof Dam. The holiday resort at this dam has been neglected. The Department of Tourism has identified this facility as one of the Tourist facilities that need to be revived. Aqua culture can also be a feature.

The challenge of governance as reflected in the report of the AD HOC COMMITTEE ON COORDINATED OVERSIGHT ON SERVICE DELIVERY which sat at Renosterberg Local Municipalities (Pixley Ka Seme District Municipality) from 17-21 May 2010 is still prevalent.

The Noupoot area should also be a feature with regards to rail revitalisation. The submissions by the municipality on their application for allocation of 400 RDP houses, the renovation of the stadium and the spinning and weaving project for which they requested the NCOP to assist them with should be pursued.

Umsobomvu

The construction of the wool processing plant seems to be a key driver of economic activity. The revival of the rail in De Aar should not be viewed in isolation. There is transect infrastructure in Huskinson that will be linked to the wool processing plant.

Ubuntu municipality

These challenges are still prevalent. This emerged during the site visit to Vanderkloof holiday resort. Funds by Tourism could not be released because the municipality could not account on funds released earlier to justify the next allocation.

"Key local government challenges which emerged during this process focused on governance, service delivery backlogs, spatial disparities, capacity constraints and financial mismanagement. The Local Government Turn Around Strategy and the Integrated Development Plans are tools to help in correcting challenges faced at a local level. In terms of governance at a local level several issues emerged namely: role clarification, administration of the municipality, role of ward committees, communication and inter governmental relations. The issue of service delivery highlighted the importance of jurisdiction and the role of inter-governmental relations. Other challenges faced at a local government level included supply chain regulations, lack of monitoring and evaluation, lack of capacity, unemployment, availability of land and inadequate bulk services

For these projects we still need to solicit a buy in from the province and municipalities.

Through the department of Tourism tourist guides will be trained. The district municipality has developed a tourist route that would depict history through the eyes of the indigenous people.

The indigenous people are not involved in this industry as tourist guide and other value ads that are tourism related. The Africans are not given an opportunity to tell their story. It is very costly to train as a tourist guide in the area. The Tourist Guild is an exclusive club.

Tourism

This programme can be an income generator for the indigenous people. They should be involved in the waste collection and processing. In this case decent permanent jobs can be created. A spirit of entrepreneurship will be generated.

Waste management

Farms that were bought under the land reform programme which were to be investigated by Land affairs to be persuaded

The NCOF can facilitate the collaboration of various departments around this project. The spinoff is that secured farms can contribute to higher profitability and generation of income. Stock farmers will be able to practice grazing farm rotation and crop farmers will have secured their crops until harvesting time.

Unfenced farms are a major challenge. Crop farmers cannot farm because their crops are destroyed by stock that grazes in unfenced land. The fencing of farms on its own can be a job creator. There are hundreds of kilometres that need fencing.

Agriculture

These challenges offer adequate opportunities for the NCOF to can have a lasting impact or legacy and contribute towards job creation.

2. Proposal

- This is a strong tourist attraction area with countless opportunities for the PDIs but who have not been absorbed into the mainstream of the industry except as providers of labour
- Waste management is another challenge in the area
- The lack of fencing for this agrarian community becomes an obstacle in enabling them to take agriculture to a higher level

- The Training centre is being renovated
- Transport is still a challenge
- The land claims issue is in process
- Water is still a challenge

On issues previously raised

The former members of the Shiloh Irrigation Scheme are also current members of the Mayme dairy cooperative. This project is a joint venture with Amadaleo Consultants. The province has invested more than R30mil. for the state of art milking parlour. This investment together with the land of the beneficiaries seems not to have been taken into account when contracts were drawn with the strategic partner. They seem to have been short changed. There are no clearly defined programmes on skills transfer.

FREESTATE

The Province launched 3 projects. Two of them received dummy cheques and one sod turning for a crèche was done. No follow through was done with the Ke Moja programme and the dummy cheques.

- The Masibambane Shilo irrigation scheme deregistration process has not been finalised.
- We need a principled decision to be taken that a programme of follow up must be developed to ensure that these projects are completed this coming financial year. Particularly those that have been in the pipeline for some time now.
- The new ones must be planned and budgeted for to ensure that work commences as speedily as possible

2. **Freemantle High school**
The school need major repairs with regards to the condition of the buildings, fencing and ablution facilities. The issue of mud schools should also be followed up particularly in Chris Hani municipality.

- Realising that this is the last budget before the elections emphasis should be placed on follow ups. The provincial week and the oversight week should be maximally utilised for this purpose
- A comprehensive report be compiled for the Presiding Officers before end of April 2013.
