- 3. (a) Dinganya Primary School is currently at 90% complete; due to be completed on the 31<sup>st</sup> October 2014.
  - Mxhume Junior Secondary School is currently at 7%; due to be completed on 28<sup>th</sup> April 2015.
  - Nobengela Comprehensive Primary School was not finished on time, an extension of time of 5 months was granted with penalties amounting to R150 000.00.
  - Zakhele Primary School the contract was ceded to another contractor as Moneymine Construction was not in a good financial standing to complete the project. An extension of time for 10 months with penalties amounting to R304 000.00.
  - Planned completion for Kubuyakwezwe Primary School was 12 February 2013, the actual completion date was 10 June 2013; the duration of the delays was 117 days with penalties of R117 320.
  - Planned completion date for Esiphondweni High School was 31 May 2012 but the actual completion was on the 22 February 2013; the duration of delays was 266 days with penalties of R 732 360.
  - Planned completion for Vuleka School for the Deaf was 02 February 2013; the contract was cancelled before the actual completion date. No penalties were charged because the contract was cancelled.
  - (b) There are no delays in current projects (Dinganya and Mxhume) as a result there are no penalties imposed on the contractor.
