RESPONSE

(a) The basic education sector (National Department of Basic Education and Provincial Education Departments) has an institutional mechanism: the HEDCOM Subcommittee on Planning, Monitoring and Evaluation. This platform affords the sector the opportunity to ensure that the national and provincial plans are aligned to the National Development Plan (NDP), the 2014-2019 Medium Term Strategic Framework (MTSF), the Action Plan to 2019: Towards the Realisation of Schooling 2030.

The education sector then develops Strategic Plans and Annual Performance Plans based on the above mentioned broader long and medium term plans. As government begins the new planning cycle, the Department of Basic Education will monitor, through the Financial Planning, Economic Analysis and Provincial Budget Monitoring and Strategic Planning and Reporting Directorates, alignment of all sector plans to the National Development Plan. Furthermore, quarterly meetings of the HEDCOM Subcommittee on Planning, Monitoring and Evaluation will ensure that all plans are aligned to the National Development Plan. Provincial Education Departments submit Quarterly Progress Reports which are analysed and feedback is provided. In view of the fact that government is beginning a new planning cycle, the scope of analysis will include tracking progress against key issues raised in both the NDP and the MTSF.

(b) Minimum Standards for Infrastructure refers to basic services which are water supply, electricity supply and sanitation facilities

Electricity

This refers to presence of some form of power supply which is **Grid electrical reticulation**, **generators**, **solar power energy** and/or **wind power energy supply**, which complies with all relevant laws.
